Oregon COVID-19 Reopening Status Report

One week after the pause in Oregon's reopening, the data continues to show that cases are increasing throughout the state. Public health is investigating many outbreaks across the state, as well as identifying increased cases that are not able to be traced back to a known case.

As OHA's modeling projected and health experts expected, Oregon is seeing a rise in cases as Oregonians begin to interact in more normal ways. In addition:

- Some of the increase in cases over the last week are due to large outbreaks in Lincoln and Union counties.
- As testing increases, the percent of positive tests is also increasing, indicating that we are seeing more COVID-19 in the state (now 3.2 percent).
- OHA has not recorded significant increases in emergency department visits for COVID-19-like infections.
- Testing in counties affected by the reopening pause indicate that they are not undertesting. (Undertesting would be indicated by a percent positive of 10 or more.)
 These counties currently have enough regional hospital bed capacity to treat COVID-19 patients.

To suppress the wider spread of COVID-19 in Oregon, OHA urges state residents to strictly follow public health guidance: wear face coverings in public when unable to maintain six feet of distance, wash hands frequently, avoid groups (especially indoors), stay home if you're sick, work from home if possible, and answer the call if you hear from a contact tracer.

I. Status of counties currently on pause and recommendations:

Multnomah County:

- Multnomah County has not had an uptrend in new hospital admissions over the past two weeks (29 total cases).
- New cases of COVID-19 increased in the previous week with almost half of cases not traced back to a known source.
- Local public health is following up on three workplace outbreaks. Timely follow-up has begun in all cases over the last week.

Recommendation: Based on these indicators, Multnomah county will be allowed to move into Phase One, joining neighboring Clackamas and Washington counties. Going forward, data will be considered comprehensively across the tri-county Portland area. Several outbreaks have cases in multiple Portland metro counties, which supports the need to look at data comprehensively across the region.

New hospital admissions are decreasing in Clackamas and Washington counties. While new incident cases are also increasing in these two counties, local public health officials have begun timely follow-up on most cases while investigating workplace and congregate living outbreaks.

Marion County and Polk

- Marion County has seen a decrease in new hospital admissions over the past two weeks, despite an approximately 20 percent increase in new cases last week (compared to the previous week).
- Marion County public health officials have begun investigating several outbreaks in a timely way.
- Polk County has not had any new hospital admissions in the last two weeks, despite a large increase in new cases in the past week (23) compared to the previous week (5).
- Polk County public health has initiated timely follow-up for all cases.

Recommendation: The data from both counties support their request to move forward into Phase Two. Going forward, the two counties for the Salem metro region will be looked at as a unit. Many of the outbreaks in this region involve residents from both counties.

Hood River County

- Hood River has only had 1 new hospital admission in the past two weeks.
- Hood River public health officials have begun timely follow-up for all new cases, and new cases have fallen by half in the last week. (21 last week compared to 42 the week before.)
- Local public health officials are following up on two workplace outbreaks.

Recommendation: The data support Hood River's request to move to Phase Two.

^{*} In a public health crisis, such as a pandemic, healthcare resources may be overwhelmed. As an important part of emergency planning, hospitals have developed their own surge plans for how to expand hospital bed capacity as needed such as for our state's COVID response. This potential expanded capacity is not reflected in HOSCAP, the state's hospital bed tracking tool. Instead, data reported to HOSCAP reflects current staffing levels and bed availability to meet today's needs.
